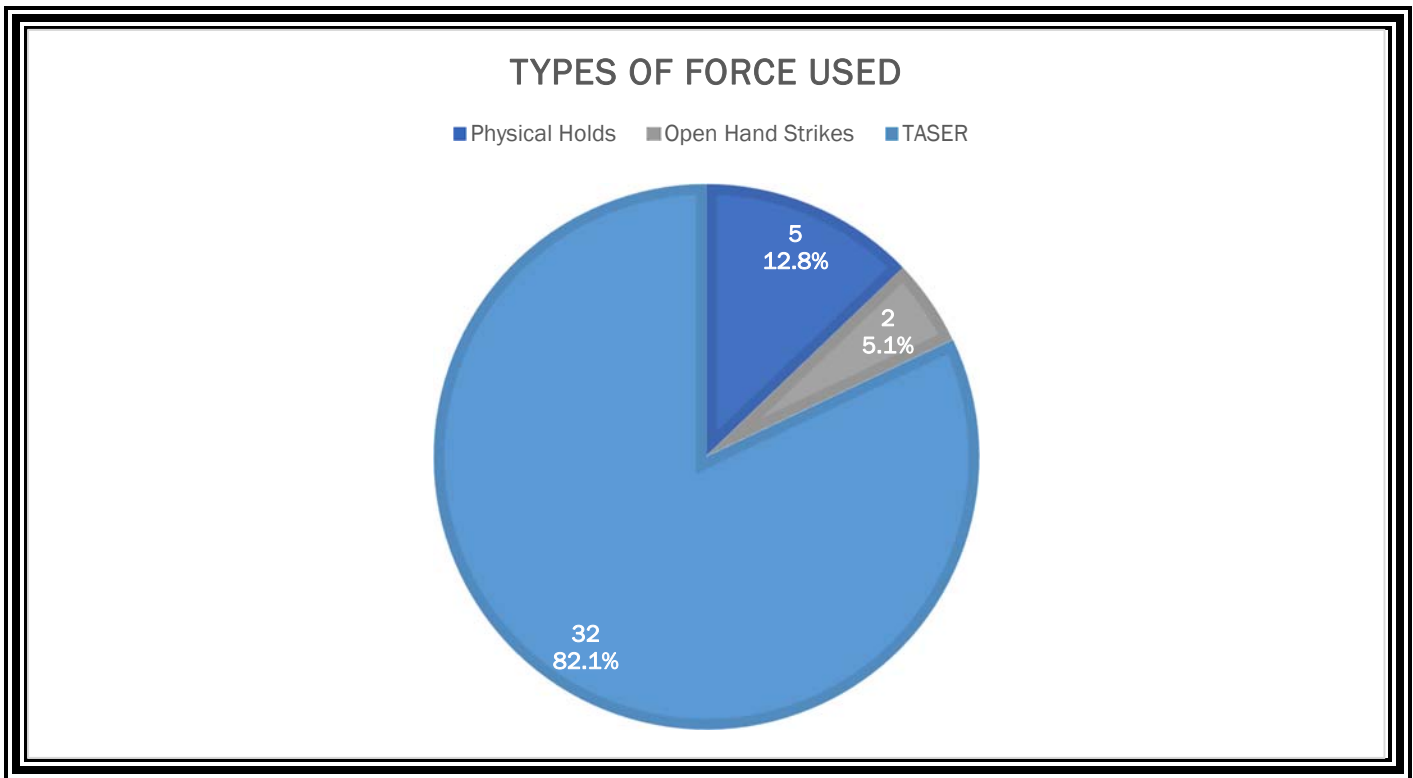
USE OF FORCE AND ARRESTS

The Lewisville Police Department *Use of Force General Order 4.1* provides police officers with procedures that must be followed when it is necessary to use force to effectively bring an incident under control while protecting the lives of officers and the public. The General Order provides direction on the use of both non-deadly force and deadly force. Deadly force is defined as any force applied in any manner by any means that could be reasonably believed to cause death or serious bodily injury. Non-deadly force is defined as force that is not intended to cause serious bodily injury or death when used.

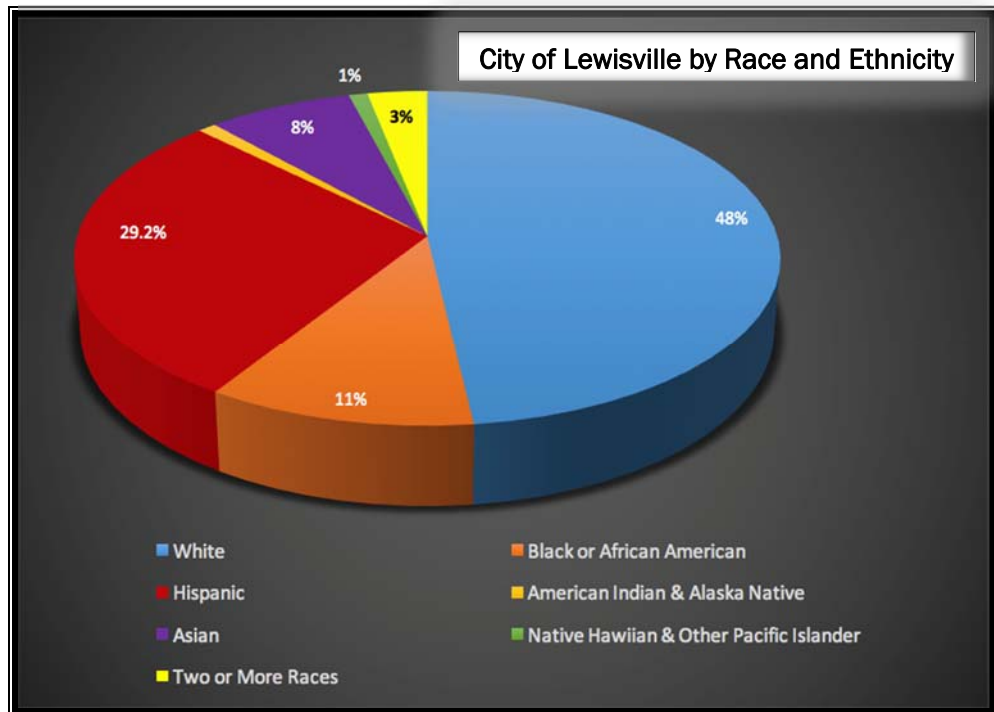
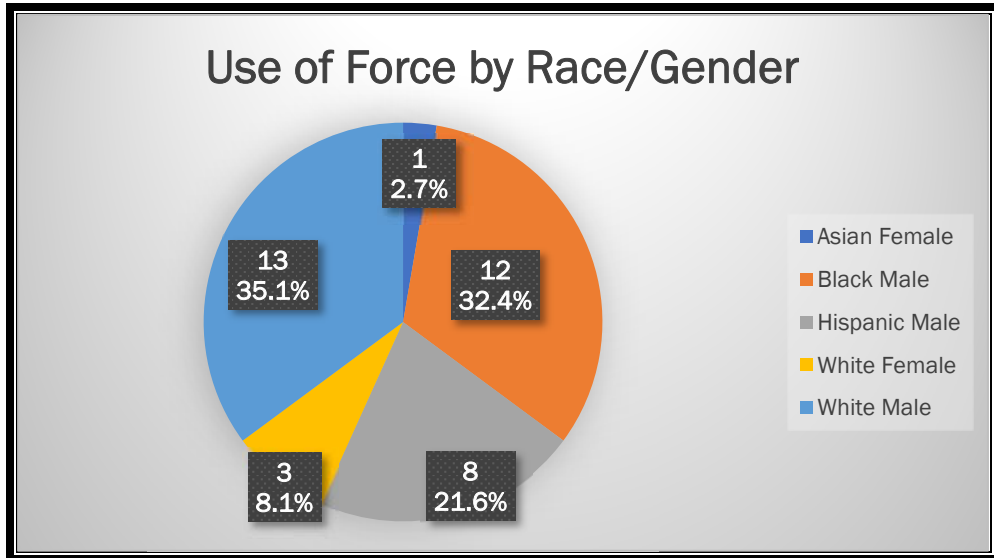
Per the General Order, the Chief of Police has a process for the review of all use of force incidents. As part of that review, an annual report is created that analyzes all use of force incidents.

In 2019, the Lewisville Police Department documented 39 officers using non-deadly force on 37 individuals. There were two incidents where two officers used force on the same individual. There were no instances of deadly force in 2019. The Lewisville Police Department Safety Review Board reviewed all incidents where force was used and found all uses of force were reasonable and within policy.

The information contained in this report provides an analysis of all 2019 use of force incidents. Below is a chart that provides a break down of all use of force incidents. The deployment of the Taser (Conducted Energy Device (CED)) was the most frequent force used in 82.1% of incidents. Physical holds accounted for 12.8%, of incidents and Open Hand Strikes accounted for 5.1%. Officers documented minor injuries to the suspects in six of the use of force incidents. None of the injuries required hospitalization. Two officers reported minor injuries after altercations with a suspects.



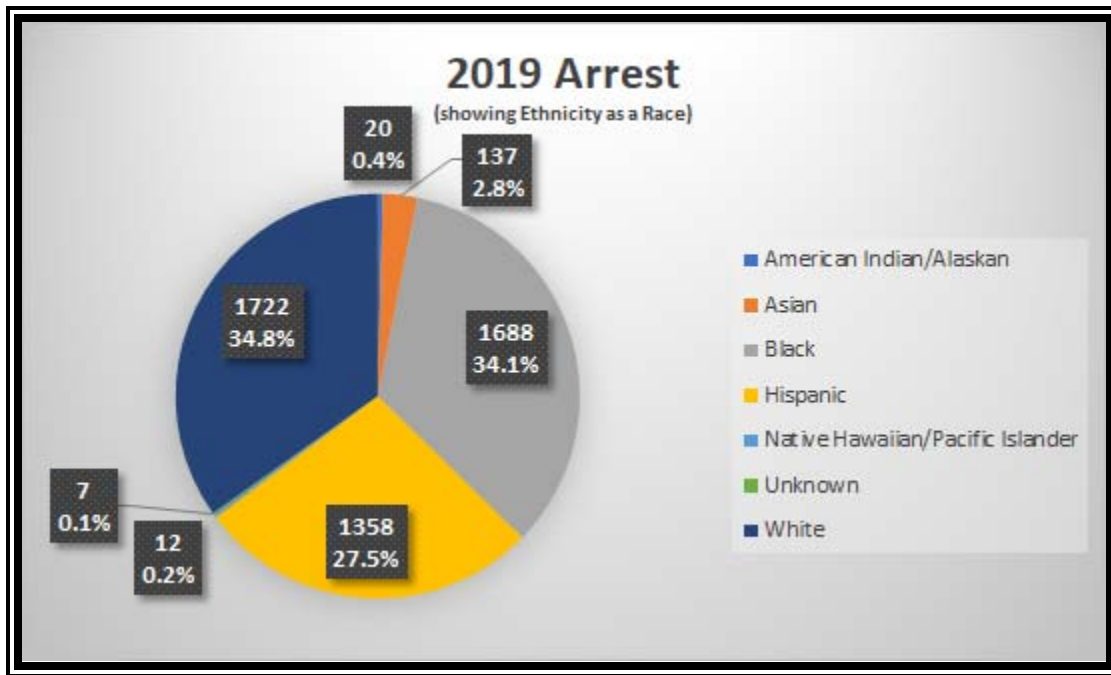
Caucasians make up approximately 48% of the population in the City of Lewisville and accounted for 43.2% of incidents involving use of force (3 females, 13 males). Hispanics make up 29.2% of the population and accounted for 21.6% of incidents involving the use of force (0 females, 8 males). African Americans make up 11% of the population and represented 32.4% of the incidents where there was a use of force (0 females, 12 males). Asians make up 8% of the population in the City of Lewisville and accounted for 2.7% of incidents involving use of force (1 female, 0 males). The two charts below show the latest demographics for the City of Lewisville and the breakdown of use of force incidents by race. Any “Race/Gender” groups for which no force was noted in 2019 are not included on the chart below.

ARREST ANALYSIS

Staff prepared an analysis by demographics of all arrests in 2019. During calendar year 2019, the Lewisville Police Department made 4,944 arrests. Caucasians make up approximately 48% of the population in the City of Lewisville and accounted for 34.8% of arrests. Hispanics make up 29.2% of the population and accounted for 27.5% of arrests. African Americans make up 11% of the population and accounted for 34.1% of the arrests. Asians make up 8% of the population in the City of Lewisville and accounted for 2.8% of arrests. Below is a chart that shows all arrests broken down by demographics.



In conclusion, the following chart correlates all 2019 arrests and use of force incidents broken down by demographics.
