### MINUTES COMMUNITY DEVELOPMENT BLOCK GRANT ADVISORY COMMITTEE (CDBG AC)

Tuesday, December 12, 2023

**Item 1:** Chris Crawford, Committee Chair, called the meeting to order in the presence of a quorum at 6:37 p.m.

**Item 2:** The committee reviewed the minutes of September 19, 2023, October 17, 2023, and November 14, 2023. Edora Butler moved to approve the minutes; Kathi Stock seconded the motion. The minutes were approved unanimously.

**Item 3:** Chris Crawford opened the public hearing and introduced committee members and City Staff. Rachel Hiles, Grants Specialist, provided an overview Lewisville's City Fund and CDBG history, past and present projects, and Consolidated Plan goals. The floor was opened for public comments.

A community member spoke to the committee about the rising rent prices and the strain it puts on seniors maintaining their housing. The committee and Elena Shehan, Grants Coordinator, gave an update on the City's focus on affordable housing and some of the recent action taken to achieve that goal.

CASA of Denton County presented to the committee about the privatization of the child welfare system in Texas, which took effect in Denton County on November 1, 2023. The private nonprofit Our Community Our Kids (OCOK) has taken over the care of children who have been removed from their homes, rather than the State controlling this process. CASA is experiencing a need for more volunteers, since this type of systematic change will mean that CASA volunteers will be the primary party with historical information about children currently in the system.

Page 2 CDBG Advisory Committee Minutes December 12, 2023

Three representatives from WeBUILT DFW introduced the committee to their organization, which is a newly formed nonprofit in the area. The organization focuses on adults with autism who struggle to find affordable living when entering adulthood. They emphasized the number of young adults with autism leaving school and struggling with a lack of support in adulthood. WeBUILT DFW explained their tie to the WeBUILT organization in Oregon and the support received from them as well as their intent to purchase a property to create housing for that cause but have struggled to find affordable options.

**Item 4:** Rachel Hiles reviewed the overall committee scores for each Backbone Support application. The committee discussed the applications and feedback on the applications. Chris Crawford led the group in discussion and determining funding awards for each applicant.

Edora Butler moved to approve the funding decisions for the Backbone Support applications; Duff Taylor seconded the motion. Funding decisions were approved unanimously.

**Item 5:** Robyn Johnston moved to adjourn the meeting; Kathi Stock seconded the motion. Meeting was adjourned at 7:54 p.m.

## We love a story with a happy ending

We recently saw an 84 year old veteran experiencing homelessness & living in his car, unable to afford housing. We were able to sit down with him and make a plan to get him the help necessary to secure housing. We were able to assist him with:

- -1 week hotel stay through a local church
- -Daily lunch & case manager assistance to search for housing
- -Found an affordable apartment in Lewisville (the last unit available at the complex)
- -Gas card to get to the complex to apply
- -Payment for the rental insurance required to move in
- -Case managers called the utility company to get connected
- -Connected him with another case worker at the Veteran office in Denton for further assistance
- -Veteran office connection was able to provide first month rent, furniture, and other necessities
- -Continued daily lunches to save on grocery costs

He has been in his apartment for a few months now and is doing very well!



#### Inclement Weather Shelter

Operated the 24 hour weather shelter for 6 days straight during the Code Blue temperatures in January.
Offered 16-20 people a warm place to stay, day and night.
