City of Lewisville CDBG Minor Housing Rehabilitation Program (HVAC Remhnak le Thlennak) Zulhphung

The City of Lewisville's Minor Housing Rehabilitation Program (HVAC Remhnak le Thlennak) (the "Program") cu City of Lewiville sin ah U.S. Department of Housing and Urban Development (HUD) nih Community Development Block Grant Program (CDBG) caah pekmi in tuahmi a si.

Tinhmi

Hi Program cu income a tlawm-in- a laivuang a hmutu inn ngei hna sinah a herhmi lumnak, thli chuahternak, le aircon (HVAC) thilri hna remhnak, thlennak, le a thar bunhnak le cu HVAC thilri remhnak, thlennak, le a thar bunhnak he aa pehtlaimi elektrik kong ah bawmhnnak pek nak ding ah tuahmi a si. Hi Program ah hin, inn ngeitu hna nih Program nih a cohlan mi rian tuah khawhnak caah bawmhnnak cu \$15,000 tiang ngah khawh a si, silole a dangdang herhca ah bawmhnnak ngahchap ah cun a tam deuh, i CDBG nih pekmi tangka chungin hman a si lai i City (the "Contractor") nih contract tuantu a thimmi nih an tuan lai. A sawktu poahpoah cu City riantuantu nih an ngah le ngahlo zoh hmasa a si lai. HVAC thilri remhnak, thlennak, siloah a thar bunhnak cu a lenglei hlanmi Ruahnakcheutu (the "Consultant") nih riantuan ding a haumi vialte a zoh hmasa hnu ah a ngah le ngah lo theih a si lai.

Aa tlak mi sinak

Hi tuah ding mi thil ah i tel tum khawh ve nak ding ah cun a tlangpi in a herh mi langhter mi hna cu a sawktu le contract tuantu an pahnih in aa tlak mi an si lai. Aa tlak mi si le si lo zoh hmasat hi tuah hmasa a herh mi a si nain, na sawk mi na ngah hrimhrim lai ti nak aamahkhan cu a si lo.

Sawktu Aa Tlakmi Sinak

Hi Program nih pekmi bawmhnnak ngah ding ah aa tlakmi sinak ding ah cun, a sawk tu cu:

- Amah tein a dir mi inn siloah inn pahnih aa pehmi inn a ngeitu a si lai, i City's Unified Development Code ("dwelling") ah fianhter ningin Lewisville Texas khuachungah a ummi le a sawktu nih a ngeih i umnak ah a hman mi inn a si lai. (Inn ngeitu cu minung pakhat lawng a si lo ahcun, a ngeitu a si mi vialte nih sawknak ca phih le bawmhnnak ngah ding ah aa tlakmi an si ve a hau lai.)
- Rian tuan awk ah timhmi inn cu upadi ningin a ngeitu sinak (title) aa tlaihnak a tlawm bik kum (2) a si cang mi a si lai. Midang he a ngeitu sinak hnatlaknak ngeih cang mi asiloah zuar ding ah hnatlaknak ngeih cang mi inn a si lai lo.
- Inn insurance a ngei lai. FEMA nih kum 100 dan ah tilian a um tiah an tinak hmun ah cun tilian ca insurance ngeih chih a herh. Tangka ngah hlan ah insurance ngeihnak tette a herh leng ah, cu insurance cu rian tuan mi an lim hlan tiang in ngeih a herh lai.

- Tuan ding ah timh mi inn cu, inn man tha tein pekmi si lengah, City ah lak mi ti man, thur hlonh man ti bantuk le ngunkhuai pek ding poahpoah tha tein pekmi a si lai i, rian aa lim hlan tiang pehzulh in pek a herh lai.
- HUD Metro FMR Area nih HUD Metro FMR Area income cazin hmangin mah kum caah a tambik income chiahmi tangah income a tlawm-in- a laivuang a si tiah ruahmi an si lai. Pawngkam Chungkhar A Laivuang Tangka Lutmi (AMFI) i 80% nak in a tlawmdeuh tangka a hmutu chungkhar lawng an i tel kho lai. Aa tlakmi sinak theihnak caah City of Lewisville nih “annual income” timi sullam cu 24 CFR 5.6099 ta a hman, hihi remh khawh a si. Appendix A and langhter mi HUD Metro FMR Area tangka hmuhmi zat cu HUD nih a herh a ti ningin remh khawh a si lai.
- Ngeihmi a dihlak ah \$20,000 leng a si lai lo (ngeihmi chungah tangka cash, checking le saving ngeihmi, stock chiah mi, tangka karh hmuntampi ah chiahmi le dan liam hau lo in hmuhkhawh mi ngeihchiah dang na ngeih mi hna an i tel).
- City nih a chuahmi sawknak ca phih cang mi a si lai.
- A sawktu cu Tangka kong Lunglinnak ah a um bantuk in a ngeitu sinak tuanvo vialte a tlinh khotu a si lai.

Tuah A Ngahmi

HVAC ti mi kihnak le lumnak seh pawl remh, thlen asilo le a thar bunh ding, silole cucu he aa pehtlai mi elektrik lei remh, thlen le a thar bunh ding ah, Appendix C ah langhter mi bantukin aa tlak ning in \$15,000 man tiang bawmhnan ngah khawh a si.

Mah tein rak remh cia cang mi pawl cu bawmh a ngah ti lo.

Bawmhnan ngah le ngahlo hi City of Lewisville nih a tha a ti ningin biakhiahnak nawl a ngei. Bawmhnan hal mi ning theng in siloin, City nih a dotdot te in zohfel nak a ngeih hnu ah remh, thlen, le a thar bunh piak ding a ngahmi a si le silo biakhiahnak a tuah lai.

A Ngahlomi Rian silole A Sawktu

- Kan remhnak i kan hrawh sual mi ruangah dah kan tuah ti lo ahcun, zoh dawhnak ca i ttamh mawihnak ding caah bawmh a ngah lo. Tahchuhnak ah, innkhan pakhat kha pang ah tlawmte kan hrawh sual ah cun, cu kan hrawhnak zawn te cu a dang he aa lawh khawh biknak in kan nalh/remh lai, a khan ning pi in tinbawsi kan thuh lai lo.
- Thlalangawng asilo le saupi a nguh lo mi thil pawl cu bawmh a ngah mi ah an i tel lo. Mini splits tiah auhmi, innchung pangah thlaimi, aircon pawl cu thilumtuning ngeih in a cheu cu bawmh a ngah mi a um; Appendix C zoh.
- Lewisville City Ordinance asilo le a tu lio International Property Maintenance Code ah a um bantukin, umnak khua nih a him lo tiah remh ding in nawl an chuah mi le ser ding mi ser lo in a um mi inn a si lai lo. A him lomi silole a him than nak ding i remhnak caah \$15,000 man nih a zat lo ding a si ah cun bawmh a ngah lai lo. City nih tih a nunnak a ruang le bawmh a ngah lo nak a ruang cu

ca in theihternak tuah a si lai.

- HVAC unit remh, thlen, asilo le a thar bunh nak ca i a herh mi thilri pikpak tete cu bawmh a ngah mi ah an i tel lo.
- A sawktu nih riantuantu hna rian an tuan lioah nek le zawmtaihnak, hnahnawhnak, le upationak nunzia langhter, asiloah City le a rian tuantu hna rian tuannak donhkhanhnak a tuah ah cun riantuan ti loin ngol khawh a si lengah hmailei ah City nih pek mi CDBG bawmhnak pawl ngah ti lo khawh a si.
- A sawktu nih bawmhnak hmuh duh ah a hman lo mi sining kong a chim ahcun bawmhnak pek a si lai lo i hmailei ah hi Program bawmhnak a ngah ti lo kho men.
- Vawlei ah a hrambunh asilo mi thial khawhmi inn asiloah a sawktu cu inn ngeitu a si lo ah cun bawmh a ngah lo.
- Insurance sin ah HVAC unit le aa pehtlai mi thilri remhnak dingah claimtuah cang i a man zong liamh cang mi cu bawmh a ngah ti lo.

Uusaapekmi/Biapi ah Chiahmi

Hi bawmhnak sawk poah le a herhmi vialte tuah dih ruangah bawmhnak ngah ding hrimhrim aamahkhan a si lo. Bawmhnak caah hmanding tangka ngeihmi cu rikhiah a si caah City nih a herhbik mi caah le a thabik tiah a ruah ning in peknak nawl a ngei.

A sawktu vialte chungin a ngah dingmi thimnak tuah tikah, City of Lewisville nih a tang lei bu chung i aa tel mi hna hi biapi ah a chiah hna lai:

- Inn ngeitu asiloah chungtel kum 62 in a cunglei a umnak ;
- Inn ngeitu asiloah chungkhar ah tlamtlinlonak a ngeimi an umnak (tlamtlinlonak ah aa tel mi hna cu Appendix B ah zoh);

Bawmhnak cu riantuantu nih an khiahmi caan chung lawng ah sawk a ngah lai. Sawknak caan a dih in riantuantu hna nih Appendix H i a ummi Hmatpeknak Catlap hmangin in hmatpek a si lai. Bawmhnak ngah le ngahlo cu Hmatpeknak Catlap i hmat ning in, a sangbik in a niambik, tiah tangka a um zat zoh chunh in pek a si lai.

Meitha Riantuanning le Sehthilri Standard

City nih tuah a herh dingmi rian kongah biakhiahnak a tuah tik ah thilri a riantuanning le saupi a nguh ding si le silo, thilri hman chung vialte zohkhenhnak ah a dih dingmi, meitha riantuanning, kum tin thilri zohkhenhnak ah a dih dingmi, thilri cawknak ah tangka a dih dingmi, thilri a fawi le har, tibantuk vialte zoh le tuak chih a si lai. HVAC a thar bunh mi poahpoah cu Energy Star a ngahmi an si lai, cun a remh in remh a si ah cun Energy Star standard he i khat in remh a si lai, asilo le Energy Star standard he i khat in remh khawh ding asiloah cun thlen piak a si lai.

Remh man cu cham than a hau lai maw?

CDBG nih pek mi bawmhnak ngah mi cu cham than a hau lo.

Lead-Based Paint (Khe-telhmi Tinbawsi)

Rian tuantu nih tinbawsi thuh mi a hrawh hnga ding a si sual ah cun 1978 hlan sakmi inn cu tuah a ngahlo ti cu a silo, nian Cozah le State nih Khe-telhmi tinbawsi caah zulhding ah chiahmi phung ningin riantuan ningcang biakhiahnak tuah a si lai. Khe-telhmi tinbawsi kong zohfelhnak le/asiloah a cang kho sual ding tihnungmi zohfelnak cu Khe kong ah thiamnak a ngeimi nih an chek lai. Tih a nung tiah an hmuh ah cun, tih a nunnak zawrter deuhnak thil hmangin tuah a si lai. Khe lei he aa pehtlaimi thil tuah mi poahpoah (test tuah, a thiammi auhnak, etc.) cu bawmnak ngahmi tangka chung in hman a si lai, nain riantuan ding biakhiah cang hnu ah tuah ding mi cu bawmhnak chungin hman a ngah lo mi a si ah cun City nih test nak i a dihmi vialte cu a liam lai.

Program nih Atambik Rikhiahmi

- Hi program ah bawmhnak a rak ngah bal cangmi inn cu rian an lim hnu thla 12 chung hi program nih a pekmi bawmhnak a ngah than kho ti lai lo.
- Bawmhnak ngah khawhmi cu, a dangdang caah ngahchihmi a um dah ti lo ah cun, a tambik ah \$15,000 a si.
- Inn khatah bawmhnak a tambik \$37,000 tiang pek mi Program a um.
- A dangdang caah bawmhnak hmuh khawhmi a tambik cu a tanglei ah a tlangpi in langhter ning bantuk in a si lai.

Bawmhnak Atambik Pekmi Lengin A Dih Dingmi

Bawmhnak sawk tik ah aa tel chih mi cu, bawmh duhmi kong kha pakhat hnu pakhat in tha tein cazin tial mi cu City sinah pek a si lai. Tuah dingmi cu bawmhnak hmuh mi nak in tam deuh a dih ding a si ah cun, a tanglei i langhter mi bantuk in rian pehzulh in tuan khawhnak ding caah a dangdang herh caah bawmhnak sawkchap ding in, silole, a si khawh ahcun, mah tein a zat lo mi liam ding tiah ca in theiternak tuah a si lai. Tuah dingmi cu a dangdang herhca bawmhnak sawkchap mi a ngah lo i, a sawktu nih mah tein liam a duh lo ahcun rian cu tuan ti lo in ngol a

si lai.

Atambik Rikhiahmi Budget chungin A Dangdang Herhca Bawmhnak

Tuah ding i timhmi ah a tambik budget ngeihmi chungin a dangdang herhca ah chiahmi hna cu Neighborhood & Inspection Services Director (Director) nih a tanglei bantuk dirhmun a si mi hna cu a pek khawh hna:

- Ruahkhawh lo tiangin dirhmun chiakha tangah a um mi hna;
- Ngandamnak le himnak caah tih a nung tiah ca in tial piak mi a ngei mi hna; asiloah
- Ngandamnak le himnak kong ah ruah lo pi in thil a can ruang ah.

A cunglei in kan langhtermi dirhmun lakah pakhat maw siloah a tam deuh a tongmi an um sual ah cun, Director nih bawmhnak caah tuahmi budget i 50% chap khawhnak nawl a ngei i, cu ti tuah a si ah cun bawmhnak cu \$22,500 a si lai. Bawmhnak pekmi lak ah a tambik zat leng in kaih piak ding nawl hal nak cu Director sin ah sawk hnu ah a dangdang herh caah pek mi bawmhnak ngah chih a hau lai. A dangdang herhmi caah a hlei in ngah chih mi bawmhnak cu program hmuitinh, timhmi le tluangten a kal khawhnak hnga a bawmchan tu caah a si lai i, HUD lamhmusaknak zulh a si lai. Bawmhnak a tambik ngah khawhmi chung in a dangdang herh ca cu a lak kar ah, a tanglei langhter mi caan ah dah ti lo cun, sawk caan voi 2 a um lai.

- Rian tuan ding timh lio le rian thawk lak kar;
- Rian aa lim cuahmah cang hnu ah ruah lo in tangka dih ding a um sual ah cun.

A dangdang herh ca i chiahmi bawmhnak cu voikhat lawng pek a si lai i, program nih innkhat ah a tambik a onh mi zat \$37,500 nak in a tam deuh a si a ngah lai lo.

Program nih a tambik a pek mi bawmhnak chungin a dangdang herh ca i chiahmi bawmhnak cu sawk poah ah pek a si lai tinak asilo i, a hramthok i zohfelnak ngeih lio ah rak hmuh/theih khawh lomi thil a can sual i hi bawmhnak nih a liamh khawh mi a si lo ah cun, City nih tuanvo a la lai lo i, tuanvo zong a ngei lo.

A dangdang herh ca bawmhnak sawk duh ah cun Director sin ah catial a hau lai. Cu sawknak catial mi ah cun rian tuan ding timhmi, rian hlei tuah a hau mi langhernak le riantuantu fialmi nih a hlei in a dih ding mi fiang tein an tial mi aa tel chih a hau lai.

Ruahnakcheutu le Contract Riantuantu Aa Tlakmi

HVAC remhnak riantuan ding le ruahnakcheutu nih hi program tang i rian an tuan chung poah a tanglei sining vialte hi an ngeih a hau lai.

- City of Lewisville Building Services Division nih theihpi mi le minkhumhmi a si lai;
- Texas Department of Licensing and Regulation nih pek mi HVAC license aa tlaihmi a si lai; cun

- HVAC caah a herhmi tuah ding halnak (RFP) chungah insurance konghe pehtlai in ngeih a herh ti mi vialte aa telmi insurance aa tlaih mi a si lai.

- Hi program tangah tuahmi thil poahpoah cu a tlawmbik kum khat (1) tal warranty pek ding a si lai. Warranty cu inn ngeitu min in a si lai; City nih warranty kong ah tawon a la lai lo. Thilcawkmi le thil a sertu kampani nih an pekmi warranty lengah khawntrek tuantu hna nih a hlei in kum khat ca cu pek a si lai.
