With a quorum present, the Old Town Design Review Committee meeting was called to order by Chair Randy Tetzlaff at 4:00 p.m. on Monday, March 25, 2024, in the Development Services Conference Room, 2nd Floor, of the Lewisville City Hall, 151 West Church Street, Lewisville, Texas.

Item 2: Approve the Minutes From the March 11, 2024 Meeting

The first item on the agenda was the approval of the minutes from the March 11, 2024 Meeting. A motion was made by Kelly Blackall and seconded by Odin Clack to approve the minutes as presented. The motion passed unanimously (4-0).

Item 3:

Consideration of a Letter of Design Approval for Twelve New Signs Associated With two Multi-Family Buildings, Located at 100 East Main Street and 151 South Mill Street; as Requested by Zach Roark, the Sign Contractor, on Behalf of the Business Owner, AMAC Holdings LLC. (24-03-9-LDA)

Grace Martin-Young, Planner I, gave a brief overview of the proposed twelve new signs associated with two multi-family buildings with a recommendation to approve the signs with the modifications as presented. A motion was made by Odin Clack and seconded by Amy Puckett to approve one monument sign; four directional signs with modifications to allow increased size, quantity, and acrylic material; four single-tenant wall signs with modifications to allow increased size and quantity; and three building markers with modifications to allow acrylic material. SUBJECT: Consideration of a Letter of Design Approval for a Multi-Tenant Wall Sign

Located at 190 West Main Street Suite 104A; as Requested by Ali Azimimotlagh,

the Business Owner. (24-04-11-LDA)

BACKGROUND

Shake Land, at 190 W Main, is a new business to Old Town Lewisville that opened in October of 2023. The Business is a restaurant use that serves ice cream and snack foods. Ali Azimimotlagh, the business owner is seeking a Letter of Design Approval for a multi-tenant wall sign that was installed in approximately September of 2023.

The owner hired a sign contractor to permit and install the sign. However, no sign permits were received prior to installation of the sign. Code enforcement sent a letter stating the permits are required.

ANALYSIS

The sign is four (4) feet tall and six (6) feet in width, totaling 24 square feet. The sign is centered over the business front and reaches beyond the edge of the articulation band. The sign is made out of vinyl and features a white border and purple striped background, in the center of the sign is an oval type shape with the brand name "Shake Land" written in a cursive font with the top portion of the letters being pink and the bottom portion purple. The text is framed by various cartoon-style full color ice cream and dessert renderings which are all outlined in purple. These elements as well are further bracketed by abstract lines in the colors pink and purple. The sign is mounted with 3/8-inch, non-corrosive galvanized bolts into the existing fascia, and lit by red LED halo lighting as well as three (3) upcast lights which are mounted onto the business awning.

The sign does not comply with the Unified Development Code's sign requirements in the Old Town Center District as they relate to:

- a. Sign materials: vinyl is not an allowed material type.
- b. Sign area: the maximum allowed size for a multi-tenant wall sign is twelve (12) square feet for a building of this size, the proposed sign is more than double this size.

Though, the Old Town Design Review Committee is permitted to allow for modifications. Further, the sign does not meet the design guidelines found in the UDC Appendix 1, chapter A-1.18 which states that signs be subordinate to the overall building architecture.

RECOMMENDATION

Staff recommends that the Old Town Design Review Committee approve the multi-tenant wall sign with the condition that it be moved to fit within the building architecture.




