With a quorum present, the Old Town Design Review Committee meeting was called to order by Vice-Chair Amy Puckett at 4:01 p.m. on Monday, April 8, 2024, in the Development Services Conference Room, 2<sup>nd</sup> Floor, of the Lewisville City Hall, 151 West Church Street, Lewisville, Texas.

#### Item 2: Approve the Minutes From the March 25, 2024 Meeting

The first item on the agenda was the approval of the minutes from the March 25, 2024 Meeting. A motion was made by Audra Smolinski and seconded by Kelly Blackall to approve the minutes as presented. The motion passed unanimously (4-0).

#### **Item 3:**

Consideration of a Letter of Design Approval for A Multi-Tenant Wall Sign Located at 190 West Main Street Suite 104A; as Requested by Ali Azimimotlagh, the Business Owner. (24-04-11-LDA)

Richard Luedke, Planning Director, gave a brief overview of the proposed multi-tenant wall sign with a recommendation to approve the sign with the modifications as presented. The applicant was present and available for questions. A motion was made by Kelly Blackall and seconded by Audra Smolinski to approve a multi-tenant wall sign with the following modifications: a) to allow vinyl sign material; b) to allow a sign area of 24 square feet; and with a condition that the top of the sign be lowered below the bottom of the brick cornice and the bottom of the sign may encroach onto the flashing of the metal canopy. The motion passed unanimously (4-0).

at 165 West Main Street; as Requested by Michael Gary of Giant Sign, the Sign Contractor, on Behalf of the Property Owner, RO Properties, the

Property Owner. (24-02-4-LDA)

#### **BACKGROUND**

State 28 is a new restaurant located at 165 W Main Street. The Old Town Design Review Committee previously approved a Letter of Design Approval for exterior modifications to this site on February 12, 2024. At the February 12 meeting, the restaurateur shared his vision for an elevated kitchen and cocktail restaurant which he anticipates bringing increased traffic to Old Town Lewisville.

#### **ANALYSIS**

The applicant is proposing to replace the existing projecting neon sign with new single tenant wall signs, one on the front and one on the rear facade of the property. The proposed signs are routed aluminum pan signs with vinyl graphics. The sign background is white and the sign features lettering and graphics in dark red and deep blue colors.

The front sign is proposed to measure eleven feet (11') wide and five feet, eight and a half inches (5' 8 ½") in height, with an area of 62.7 square feet. The rear sign is circular measuring 84 inches in width and height, with a total area of 49 square feet. Both signs will be lit by gooseneck lighting, with three lighting fixtures over the front sign, and two fixtures over the rear sign. The specific product information for the lighting fixtures has not yet been decided, but they are proposed to be black metal.

The front sign features the Business name "STATE 28" in a capitalized dark blue sans-serif font. This is framed by rows of stars above and below as well as a graphic of Texas above and capitalized serif letting in a half circle stating "KITCHEN & COCKTAILS" below, all of which are in the dark red color. Lastly, these design features are outlined in dark blue line work with a thin white border creating detailed edges and unique sign shape.

The rear sign proposes a simplified version of the primary sign with a circular shape with the focus being the business logo with the red Texas graphic with white numbers framed by dark blue, capitalized, serif font stating "STATE" on top, and "LEWISVILLE" on the bottom portion of the sign. These primary graphics are bracketed by blue and red line work as well as the phrase "EST." and "2024" in the dark blue serif font at a zero-degree angle at the approximate middle of the sign.

The sign standards for the Old Town Center overlay district specify that signs may be a maximum of fifty (50) square feet on primary facades and twenty-five (25) square feet on secondary facades. These signs exceed the allowed size by 25% on the front façade and 96% on the rear façade. The Old Town Design Review Committee is permitted to allow for a modification to the sign area.

The signs do not meet the Old Town design guideline suggestions to a) only use colors from a historical color palette and b) to provide positive contrast with lighter details on a darker background. Though, the signs do meet the suggestions of lighting type, use of serif and sansserif fonts at different scales, placement relative to building architecture, using less than five colors, and the front sign provides detailed edges as requested by the guidelines.

#### **RECOMMENDATION**

Staff recommends that the Old Town Design Review Committee approve the single tenant wall signs with modifications to allow for the larger sign areas.

Located at 190 West Main Street Suite 104A; as Requested by Ali Azimimotlagh,

the Business Owner. (24-04-11-LDA)

#### **BACKGROUND**

At the April 2, meeting of the Old Town Design Review Committee a multi-tenant wall sign was approved unanimously (4-0) with a condition to lower the placement of the sign so that the brick was not covered.

Since receiving the letter of design approval, the applicant proceeded to lower the sign to comply with the condition, though the sign was unable to be moved any lower and still does not fit within the sign band on the building.

#### **ANALYSIS**

The applicant reached out to the planning department on Thursday, April 18<sup>th</sup> to request the sign be allowed to remain, though they were unable to meet the conditions of approval. The sign was lowered five inches (5') from the previous location, though it still covers the architectural band of the building. The applicant is unable to lower the panel without the panel being cut, and requests the sign be approved at the current placement.

#### **RECOMMENDATION**

Staff recommends that the Old Town Design Review Committee review consider the request.
