SUBJECT: Consideration of a Letter of Design Approval for a Multi-Tenant Wall Sign

and Window Sign; Located at 423 Elm Street; as Requested by Sara Higgins,

the Applicant and Business Owner. (24-07-21-LDA).

#### **BACKGROUND**

Vista Physical Therapy has moved from 475 Elm Street to 423 Elm Street, Suite 100. The new location is within the Old Town Design District and requires a Letter of Design Approval for a multi-tenant and window sign.

#### **ANALYSIS**

The sign design includes the words "Vista" as the primary text and "Physical Therapy" as secondary text in sans serif font. The letters are blue to match the business's brand standards. All letters are made from aluminum. The sign meets the design guidelines by use of sans-serif lettering at different scales, use of less than five colors, and positive contrast.

The sign standards for the Old Town Center Overlay District specify that there may be one multitenant wall sign with a maximum size of 20 square feet. This sign is the only secondary wall sign and measures a total of 66.75 inches wide and 24 inches tall. The total area of the sign is 11.12 square feet, meeting the area requirements. There is a temporary banner sign on the building today.

The tenant is also seeking an LDA for a window sign. The window sign matches font and style of the multi-tenant sign. Additional elements include lettering that details the business's website, phone number, and operating hours. All letters are made from white vinyl graphic.

The window sign standards for the Old Town Design District specify that maximum area is 30% of the total glass area of the window on which the sign is placed. The area of the window sign is 20% of the total glass area of the window.

All signs are compliant with Old Town Design District standards.

#### **RECOMMENDATION**

Staff recommends that the Old Town Design Review Committee approve the signs as presented.




