Lewisville Gridsters, Retired Farmer Stop BankBandit's EndRun

LEWISVILLE, Denton Co., Texas, Sept 30.—A retired farmer and the Lewisville high school football team combined here Monday afterto capture a bank robber.

Within a few hours after a slightly built, 23-year-old man in a light-colored hat walked into the Lewiswille State Bank and said, "Boys, I mean business," County Attorney Baldridge had obtained a signed statement from a Dallas resident.

Baldridge said charges would be filed Tuesday against the holdup man, whose statement said he committed the robbery to pay off his debts.

Assistant Cashier B. N. Savage said it was about 4:45 p.m. when the robber walked in through a rear door, flourished his pistol, and twice repeated his "I mean business" line.

Begin to Step Around.

"We began to step around then," said Savage, who was ordered into the vault along with A. Hayes, President G. C. Hedrick and Bookkeeper B. L. Dunagan Jr.

The robber then recalled Hayes

to ask him how to close a side door which opened out to Highway 77. When Hayes re-entered the vault he slammed the vault door and called Miss Willie Sparks, the town telephone operator. Miss Sparks sounded the fire siren, called the city hall, and the county sheriff at

Denton.

The robber, who had brought his own paper sack, scooped up \$1,046 and fled out a back door.

At a cotton gin at the rear of the bank, he ordered E. G. McCombs, who runs the gin, to start a small pick-up truck nearby.

When McCombs could not start

the truck the robber shouted to gin manager W. W. Sherill, who happened to be using the phone,

"Stop that telephone talking and get out here."

Sherill just looked him in the eye and didn't budge. The robber began running across the field near the football stands as a woman screamed, "There goes the man who robbed the bank!"

'When he saw me hit the ground with that gun he started begging for himself. He said he didn't want to hurt anybody," Hilliard related.
